A Hunter Pace is an opportunity to ride out with friends on a glorious (rain or shine) Fall day, fast or slow, jumping or going around the jumps, and to have a grand time doing it. It is disguised as a competition. As a competition the winners are those in each division who come in at the time closest to the optimum time. The optimum time is roughly determined by the speed at which a fox hunter would safely negotiate the terrain.

The optimum time is predetermined.

(Walk = 100-120 mpm, Trot = 220-240 mpm, Canter = 350-400 mpm)

*Helmet and boots with heels are required.

Rolling Pumpkins: (Walk) Approximately 2 Kilometers
Floating Ghosts (Walk/Trot) Approximately 5 Kilometers
Flying Witches: (Walk/Trot/Canter) Approximately 10 Kilometers

For those who love the XC phase of Eventing: Add a Black Cat Run!

Black Cat Run: 1000 meter XC course (8—10 obstacles) to be ridden at 350 mpm
Judged only on time. Multiple levels of jumps available. All jumps optional.

Haunted Hollow Hunter Pace

Definition of Divisions

All divisions are ridden in teams, except for the Black Cat Run. The competition is judged on time. The winners are those who complete their ride in the time closest to the optimum (not the fastest) time. Each division's course will be marked and maps will be available. All jumps are optional.

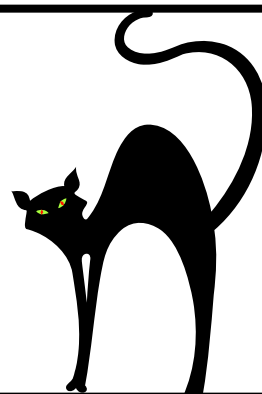
Rolling Pumpkins: This is done at a leisurely walk. The purpose is to enjoy the beautiful surroundings, stop to look around and have time to chat with your teammate. This division will be approx. 2 kilometers long, with no water crossings.

Floating Ghosts: This is the pace of a brisk walk and trot. Still time to look around, just without being too lazy. There will be small obstacles on course. You may jump them for fun or go around. This division will be approximately 5 kilometers long (may have a water crossing).

Flying Witches: This is done at a walk, trot, and canter. You might be able to see your surroundings at a glance. Take a quick look because they will fly right on by. There are bigger obstacles on course. You may jump them for fun or go around. Division will be approximately 10 kilometers long, with 2 water crossings.

WHY NOT ADD A BLACK CAT RUN?

Black Cat Run: A 1000 meter XC course with 8 to 10 obstacles. Jumps ranging from 18" to 3'3". All fences are optional. A great tune up for your next recognized event. Competition judged only on optimum time (350 mpm). Extra runs may be purchased at the event, time permitting.



Divisions will be ridden through open fields and woodland trails, with varied terrain including hills, rock outcroppings, and water crossings.

The term "Rider" shall mean not only the undersigned, but also, any minor of the undersigned, and also any person who uses any portion of the property, equipment, horses or facilities owned or leased by ASHLAND FARM with permission of the undersigned. Undersigned hereby releases ASHLAND FARM, ASHCO HOLDINGS, LLC, MARY M. McCLINTOCK TRUST, CATHERINE CLAY CALHOUN IRREVOCABLE TRUST, CLAY CALHOUN, LUCY CALHOUN, their agents, officers, directors, employees, trainers, successors, assigns, executors, heirs and administrators and any landowner from any and all claims, causes of action, demands, obligations and liabilities - which are now existing or hereafter mature or accrue at any time - arising out of or related in any fashion to the undersigned's or Rider's use of any property, equipment, horses or facilities owned or leased by ASHLAND FARM, except for ASHLAND FARM's gross negligence or ASHLAND FARM's intentional acts.

Furthermore, the undersigned acknowledges and understands that horseback riding or other participation in activities at ASHLAND FARM may involve substantial risk of bodily injury, death, property damage and other dangers including, but not limited to, bodily injury or death resulting from kicks and bites, falling off horses or horses falling on Rider, being dragged by a foot caught in the stirrups, Rider being thrown by horse, equipment failure or collision with horses or vehicles or other inanimate objects.

In the event Rider or any of the designated individuals is a minor, the undersigned, on behalf of said minor, does hereby consent to any x-ray, anesthetic, medical or surgical diagnosis or treatment and hospital service that may be rendered to said minor under the general or specific instructions of any physician or hospital. The undersigned acknowledges that this consent to medical treatment is given in advance of any specific diagnosis or treatment which may be required, but is given to encourage ASHLAND FARM, any hospital staff and physicians to exercise their best judgment as to the requirements of such diagnosis or treatment. The undersigned hereby agrees to pay all fees and expenses of doctors, hospitals, ambulances and other medical expenses reasonably and necessarily incurred.
